

APPENDIX A: NPM Site Evaluation Criteria

Rating	Description
5	Site offers 4 or more clinical services. Pharmacists are actively performing clinical services on a daily basis. This may include year-round immunizations, CMR, health screenings, med sync appointments, etc. Has at least 1 collaborative practice agreement outside of an immunizations protocol. Pharmacy has adequate staff, space, and technology to do TCT during the majority of business hours Monday-Friday.
4	All pharmacists on staff have training or certification to offer several (3 or more) clinical services. Pharmacists provide services to 4 or more patients per week. The site has a protocol in place to provide a broad spectrum of immunizations and provides immunizations routinely (2 or more per week). Pharmacy staffing may limit the ability to provide TCT during part of the business-day, but TCT can be done for at least 6 hours Monday-Friday. Technology and space are adequate.
3	All pharmacists on staff are certified to provide immunizations and have training or certification to provide MTM services. The site has a protocol in place to administer one or more vaccines. Pharmacists provide immunizations routinely (2 or more per week), and occasionally provide other services (2-4 patients per month). Pharmacy staffing may limit TCT activities to 4 days per week. Technology and space are adequate.
2	Site occasionally provides immunizations (2-4 patients per month) and does not offer other clinical services (or is in the process of developing clinical programs). The majority of staff would need further professional development to provide clinical services. Staffing may limit TCT activities to 2-3 days per week. Technology or space needs minor updating.
1	Pharmacists at this site would need further professional development to provide clinical services. Pharmacists lack certifications/credentials/training to provide clinical services. Site is not currently developing any clinical programs. The pharmacy is not adequately staffed to implement TCT. Technology or space needs major updating to be considered for inclusion in NPM initiative.
