## NCPA, FBI LEEDA and Purdue Pharma L.P. Join Forces to Fight Pharmacy Crime

## NCPA Declares April 14-18 "Protect Your Pharmacy Week"

**Alexandria, Va. (April 1, 2008)** — Today, the National Community Pharmacists Association (NCPA), FBI LEEDA (Law Enforcement Executive Development Association) and Purdue Pharma L.P. announced a partnership to combat pharmacy crime by improving pharmacy safety and security. The partners declared the week of April 14-18 as "Protect Your Pharmacy Week" and encouraged pharmacists in all practice settings to take steps to protect staff and patients from pharmacy crime, including prescription drug theft. NCPA members will receive a free "Protect Your Pharmacy Now" toolkit with resources to assist them in improving pharmacy security.

"Community pharmacists can use the materials provided not only to help law enforcement apprehend pharmacy robbers, but to gain access to important information on robbery trends and patterns that will help reduce their vulnerability to theft," said Bruce Roberts, R.Ph., executive vice president and CEO of NCPA. "By making this information available to pharmacists, we hope to reduce the number of pharmacy thefts across the country."

The "Protect Your Pharmacy Now" toolkit will include a window poster, decal, and a free RxPATROL<sup>®</sup> training DVD on pharmacy crime. NCPA members will also receive information on discounts on closed-circuit TV cameras, recorders, and surveillance equipment along with safety and security tips from law enforcement professionals. The Community Pharmacy Foundation is helping to support the toolkit through an unrestricted grant.

With a renewed national spotlight on prescription drug abuse, it is important to note the related issue of pharmacy crime. Despite the fact that the theft of controlled substances is a federal offense punishable by 20 years in prison, there are indications that robberies, burglaries, fraud and other types of diversion to obtain controlled substances in our nation's pharmacies is on the rise. It is estimated that prescription drug crime is the source of between 25-30 percent of the country's drug problem, according to statistics from the U.S. Drug Enforcement Administration and the National Association of Drug Diversion Investigators (NADDI).

RxPATROL<sup>®</sup> (Pattern Analysis Tracking Robberies and Other Losses) is a collaborative effort between the pharmaceutical industry, pharmacy community and law enforcement to collect, collate, analyze, and disseminate pharmacy theft information to pharmacists, loss prevention professionals, and law enforcement agencies. Launched in 2003 by NCPA, NADDI, and the Pharmaceutical Security Institute (PSI), and Purdue, RxPATROL<sup>®</sup> helps protect the pharmacy environment and ensure legitimate patients' access to life-sustaining medicines. Collaborating with Crime Stoppers and other anti-crime organizations across the country further enhances RxPATROL<sup>®</sup>'s efforts to disseminate pharmacy crime information with public alerts and cash rewards to help law enforcement identify and apprehend pharmacy crime suspects.
